Considering the foregoing, however, I/we grant permission for the above-named student to participate in any and all youth group activities including any that may require transportation to a location away from the Montrose Church campus, notwithstanding the risks associated with the COVID-19 virus and group activities.

I/we agree to truthfully disclose to the youth group volunteers and/or an employee of Montrose Church any and all information necessary to aid in the prevention and reduction of the spread of COVID-19 which includes, but is not limited, to any exposure to an individual outside of your immediate family who has symptoms of or has tested positive for COVID-19, and the name of any member of your immediate family who displays known symptoms of or has tested positive for COVID-19 specifically the above-named student.

Further, I/we agree to comply with any and all daily protocols to screen for COVID-19 that are set forth by the administration of Montrose Church, including temperature checks upon arrival to the youth group on church campus. Any information disclosed will be kept confidential by Montrose Church staff or volunteers to the extent that can be done to still be able to lawfully report positive cases to authorities and families.

I further agree on behalf of myself, the student named above, and my spouse, our heirs, successors, and assigns, to
